Dear Secretary Jewell,

We write today regarding the 2017-2022 Outer Continental Shelf Oil and Gas Leasing Program. In January 2015, the Bureau of Ocean Energy Management released the Draft Proposed Program for the 2017-2022 Five-Year Program. The Draft Proposed Program proposes opening areas in the Mid and South-Atlantic planning areas for oil and gas development, spanning from Virginia to Georgia. As your Department prepares to release the Proposed Five-Year Program, we respectfully request that you remove the Atlantic planning areas from inclusion in the program.

In 2010, the Department of the Interior released a proposed 2012-2017 Five-Year Program that would have opened a broad swath of the Atlantic coast from Delaware to Florida for oil and gas development. Tragically, just weeks after this proposal was released an explosion occurred on the Deepwater Horizon drilling rig and the ensuing oil spill created a massive environmental disaster impacting the entire Gulf of Mexico region. In the aftermath of this disaster, Congress created the National Commission on the BP Deepwater Horizon Oil Spill and Offshore Drilling. Unfortunately, Congress has failed to enact virtually every reform recommended in the commission's final report.


Coastal communities along the Atlantic coast are all dependent upon a clean, safe and ecologically vibrant environment to support their economies. Opening areas in the Mid and South-Atlantic to oil and gas development will put all of this at risk. In Atlantic coast states, almost 1.4 million jobs are connected to fishing, tourism and recreation, leading to over \$95 billion in gross domestic product. According to 2010 census data, 39 percent of the U.S. population is concentrated in counties directly on the shoreline. As the Deepwater Horizon spill clearly showed, oil spills do not respect state borders. A spill anywhere in the Atlantic would cause environmental damage all along the coast. We simply cannot risk the health and vitality of our coastal communities for the sake of expanding oil and gas development.

While we are steadfastly opposed to offshore drilling in the Atlantic Ocean, we are not opposed to harnessing energy from the ocean. But this energy must come from renewable methods such as wind power, and not fossil fuels that will threaten the ecological vitality of the region. The Atlantic Ocean has tremendous untapped potential for development of offshore wind energy production. Your agency has taken positive steps by leasing federal waters for wind energy development in the Atlantic Ocean. We encourage you to focus your agency's efforts on development of this clean, renewable energy resource that will not have a damaging impact on the health of the Atlantic Ocean and the economies of coastal communities.
